Fireworks Rules and Information

Bossier's fireworks ordinance allows fireworks to be set off within the city limits from December 23 through January 1 between the hours of 10 a.m. and 10 p.m. There is an exception on New Year's Eve when fireworks may be discharged until 12:30 a.m. Persons who discharge fireworks outside the designated dates and time periods can be subject to fines of up to \$500 or up to 60 days in jail. When setting off fireworks keep these safety tips in mind to help prevent injuries: Always purchase fireworks from an established and reputable retail outlet. Young children should never be given fireworks to handle alone. Responsible adult supervision is a must. Never shoot, aim or throw fireworks at people or animals. Keep a bucket of water handy for emergencies (ideal for soaking hot sparklers). Never try to re-ignite fireworks that have failed to discharge. Douse with water and wait 15 minutes before properly disposing. Be aware of dry conditions. Use common sense. Never ignite fireworks on or near areas of dry vegetation. Doing so could spark fires.

Yummy Baked Beans

Consumers Beware

There have been scam emails, text messages, and phone calls going around from scammers claiming to be with Apple, Microsoft, UPS, etc. Please be very cautious when receiving these items that contain attachments. You should **never** open any attachment on an email that is suspicious. Generally, these vendors don't send emails with attachments unless you requested something specific from them. They also don't call you, asking for personal information. So never answer personal questions from a call stating they are Apple, Microsoft, or the bank! The scammers like to send emails telling you there is a purchase for a certain amount and to cancel or view it, click on the attached invoice or document. **Do Not Do That.** Another way to check with emails is to look at the email it is coming from. Here are a few examples of "phishing emails".
