Children 12 and under MUST BE ACCOMPANIED BY AN ADULT AT ALL TIMES.

A few plants that can help keep mosquitoes away:



Lavender:

Lavender's strong fragrance can deter mosquitoes.



Basil:

Basil's scent is another natural repellent, and it's a great companion plant for gardens.



Rosemary:

Rosemary's pungent aroma helps to keep mosquitoes away.



Mint:

Mint, including spearmint and peppermint, has a strong fragrance that repels mosquitoes.



Catnip:

While cats are attracted to catnip, mosquitoes are not, making it a good repellent plant.



Lemongrass:

Lemongrass contains citronella oil, which is a well-known mosquito repellent.



Citronella Plant:

A few other plants that may help repel mosquitoes include lemon balm, sage, eucalyptus, and certain geranium varieties.

Putting any of these in the area where you hang out works well. I do it every year on the patio and in the back yard.

Citronella candles also work great.

A FEW REMINDERS FOR ALL RESIDENTS:

No cars should be parked on the street overnight.

Basketball goals should also be off the street when not in use.

Campers and Trailers should not be "stored" in driveways for extensive periods of time.

Lawns should be mowed and standing water drained to help prevent mosquitoes from breeding as much as possible.

Remember that CPR classes will be paid for by the HOA if someone is interested in being an attendant or a lifeguard but needs CPR classes.

The lifeguard is responsible for lifeguard classes, however. You have to be 16 years old to be a lifeguard and 18 to be an attendant. Attendants don't need to be lifeguard certified but they still must have CPR certification.
